



## MHEC CONTRACT # MC11-C07 FURNITURE

**CONTRACT EFFECTIVE DATES:** July 1, 2015 – June 30, 2019

**BASIC MHEC MEMBER DISCOUNT:** \$1.00 - \$20,000 list = 38% discount

**VOLUME MHEC MEMBER DISCOUNT:** \$20,001 + list = 42% discount

**MINIMUM ORDER:** N/A

**CASH TERMS:** Net 30 Days

**FREIGHT TERMS:** F.O.B. Woodridge, IL – freight is prepaid and added to invoice (freight and installation charges will be quoted to MHEC member by authorized dealer)

**GEOGRAPHIC COVERAGE:** This contract valid for the states of Connecticut, Massachusetts, Maine, New Hampshire, Rhode Island and Vermont.

**CREDIT CARDS:** We accept Visa, MasterCard, American Express and Discover.

**LEAD TIMES:** Lead times vary from 5 days to 6 weeks or more depending on product and quantities ordered.

**WARRANTY:** All products and parts are warranted against defects in materials and workmanship for the period of two years after shipment. Warranty is void if product is damaged through accident, improper use, abuse or alteration.

**LIMITATION OF LIABILITY:** Magnuson Group's liability for any and all losses and damages to buyer resulting from any cause shall be limited only to the replacement or repair of the product.

**RETURNS/RESTOCKING:** Merchandise may not be returned without prior written consent. Returns are subject to a 30% restocking charge. Product must be unused and in original cartons. Customer pays return freight charges.

**NON-STOCK ORDERS:** All orders for items that are not in stock may require a 50% non-refundable deposit at time of order placement. The order will not be processed until the deposit is received.

**SHIPPING DAMAGE/SHORTAGE CLAIMS:** All shipments should be inspected carefully on delivery, and any apparent damage or shortages noted as exceptions on all copies of the delivery receipt. Notification of shortages or concealed damage must be made to the delivering carrier within 3 days of receipt. Claims of either visible or concealed damage should be presented without delay to the carrier by the consignee.

**SHORTAGE CLAIMS:** Shortage claims reported 30 days beyond shipment date will not be honored.

**DESIGN CHANGES:** Magnuson Group reserves the right to improve product design, construction and quality without notice.
